PANOCHE DRAINAGE DISTRICT RESOLUTION NO. 807-22

A RESOLUTION OF THE BOARD OF DIRECTORS PROCLAIMING A LOCAL EMERGENCY,
RATIFYING GOVERNOR NEWSOM'S MARCH 4, 2020, PROCLAMATION OF
A STATE OF EMERGENCY, AND AUTHORIZING REMOTE TELECONFERENCE MEETINGS OF THE
LEGISLATIVE BODIES OF PANOCHE DRAINAGE DISTRICT THROUGH APRIL 28, 2022
PURSUANT TO BROWN ACT PROVISIONS

WHEREAS, the Panoche Drainage District is committed to preserving and nurturing public access and participation in meetings of the Board of Directors; and

WHEREAS, all meetings of Panoche Drainage District's legislative bodies are open and public, as required by the Ralph M. Brown Act (Cal. Gov. Code 54950 – 54963), so that any member of the public may attend, participate, and watch the District's legislative bodies conduct their business; and

WHEREAS, the Brown Act, Government Code section 54953(e), makes provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and

WHEREAS, a required condition is that a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558; and

WHEREAS, a proclamation is made when there is an actual incident, threat of disaster, or extreme peril to the safety of persons and property within the jurisdictions that are within the District's boundaries, caused by natural, technological, or human-caused disasters; and

WHEREAS, it is further required that state or local officials have imposed or recommended measures to promote social distancing, or, the legislative body meeting in person would present imminent risks to the health and safety of attendees; and

WHEREAS, such conditions now exist in the District, specifically, on March 4th, 2020, Governor Newsom proclaimed a State of Emergency due to the COVID-19 pandemic and such proclamation has not as of the date of this Resolution been lifted; and

WHEREAS, due to what may be the sensitivity of some members of the public as well as to members of the Board and District staff, the contagious nature of COVID-19, including variants of the virus, and current guidance from federal, state, and local agencies that social distancing reduces the transmission of the virus, meeting in person would present imminent risks to the health or safety of attendees; and

WHEREAS, the Board of Directors does hereby find that the current status of the COVID-19 pandemic has caused, and will continue to cause, conditions of peril to the safety of persons within the District that are likely to be beyond the control of services, personnel, equipment, and facilities of the District, and desires to proclaim a local emergency and ratify the Proclamation of a State of Emergency by the Governor of the State of California; and

WHEREAS, as a consequence of the local emergency, the Board of Directors does hereby find that the legislative bodies of Panoche Drainage District shall conduct their meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and that such legislative bodies shall comply with the requirements to provide the public with access to the meetings as prescribed in paragraph (2) of subdivision (e) of section 54953; and

WHEREAS, District notices and agendas shall provide a reasonable means for members of the public to meaningful participate in public meetings of the District; and

NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

- 1. The Board of Directors of the Panoche Drainage District hereby finds and determines the above Recitals are true and correct and are incorporated herein by this reference.
- 2. The Board hereby proclaims that a local emergency now exists throughout the District, and meeting in person would present a significant risk to the health and safety of those participating in person.
- 3. The Board hereby ratifies the Governor of the State of California's Proclamation of State of Emergency, effective as of its issuance on March 4, 2020.
- 4. The General Manager, or his designee, and legislative bodies of the District are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including conducting open and public meetings in accordance with Government Code section 54953(e) and other applicable provisions of the Brown Act.
- 5. This Resolution shall take effect on March 29, 2022, and shall be effective until the earlier of (i) April 28, 2022, or (ii) such time as the Board of Directors adopts a subsequent resolution in accordance with Government Code section 54953(e)(3) to extend the time during which the legislative bodies of the District may continue to teleconference without strictly complying with certain provisions of the Brown Act due to the ongoing COVID-19 pandemic and resulting State of Emergency.

PANOCHE DRAINAGE & WATER DISTRICTS MARCH 22, 2022 JOINT BOARDS WORKSHOP SUMMARY OF DRAINAGE MANAGEMENT & 2022 PRIORITIES

Background:

Panoche Drainage District (PDD) is a key provider of drainage services within the approximately 97,000 acre Grassland Drainage Area (GDA). PDD works with our GDA drainage partners at Camp 13 Drainage District, Charleston Drainage District, Firebaugh Canal Water District, Pacheco Water District; the San Luis & Delta-Mendota Water Authority (SLDMWA); the Grassland Basin Authority (GBA); state and federal stakeholders, including the Regional Water Quality Control Board (RWQCB) and Reclamation (USBR); and a myriad of interested parties, including the Bay Institute, Environmental Defense Fund, and the Contra Costa Water District.

- Regional drainage management essentially occurs at four levels:
 - On-Farm: Individual landowners are responsible for the operation and maintenance of their tile lines and drainage collecting sumps;
 - PDD: The PDD is responsible for the operation and maintenance of drainage conveyance channels that generally carry drainage to the San Joaquin River Improvement Project (SJRIP). PDD labor for administration, operations, and maintenance is provided by the Panoche Water District (PWD).
 - <u>SJRIP</u>: The SJRIP constantly manages regional sub-surface drainage. The project is administered by the GBA. Agriculturally induced drainage must be entirely managed within the GDA. This is achieved primarily on the SJRIP. No discharge of agricultural drainage is allowed from the GDA. Stormwater management also occurs regionally and at the SJRIP but when intra-regional systems' capacity is met, discharge of stormwater is allowed under the RWQCB's Water Discharge Requirements (WDR) Order R5-2015-0094 through the Grassland Bypass Project (GBP).
 - GBP: The GBP manages stormwater discharges when necessary. The project is administered by the SLDMWA. The SLDMWA holds agreement with the USBR for the use of the San Luis Drain and the permit with the RWQCB for the discharge of stormwater into the San Joaquin River. The PDD provides for the operation and maintenance of the GBP.
- The PDD spans nearly 47,000 acres and encompasses four water districts (PWD, Eagle Field, Oro Loma, and Mercy Springs), a portion of the Central California Irrigation District, and "white areas" in western Fresno and Merced counties.
- The PDD provides administrative and field services to Charleston Drainage District and the San Luis & Delta-Mendota Water Authority and administers grants for the implementation of the Westside Regional Drainage Management Plan.
- Almost the entirety of the SJRIP lies within the PDD boundaries, relieving the program of property taxes that would be otherwise due and partially defining the service area of the GBA.
- The PDD maintains about 32 miles of drains serving 65 tile sumps within its boundary.

2022 Priorities:

- Adoption of the Fiscal-Year Ending 2023 Budget and Drainage Service Fee;
- Selection of a financial auditor;
- Grant Administration:
 - Complete Tile-Sump SCADA Project;
 - Award Stormwater Management Basins Construction Contract and commence construction;
 - Secure DWR approval for Grassland Bypass Channel San Luis Drain Operable Gates;
 - Extend Grant Agreement;
 - Work with GBA to develop new lands within the SJRIP;
 - Work with SLDMWA/GBA to identify future projects and priorities, e.g. conveyance.
- Annexation:
 - A&H Investors
 - Sran Family Orchards
 - New SJRIP Expansion Lands

PDD has accepted two private landowner requests for annexation. PDD will also seek to annex lands recently acquired to expand the SJRIP and relieve the project of the current property tax burden.

Annexation will add approximately 3,000 acres of land, approximately 350 of which are owned by PDD. Annexation will ensure effected landowners comply with the GDA WDR Order R5-2015-0094-03; expand the drainage cost allocation base; recover costs from drainers previously not paying for service and provide future revenue to the PDD, SLDMWA, and GBA; and reduce SJRIP operational cost by about \$29,000 annually by relieving the current property tax property burden.
