CALL TO ORDER

President Barcellos called the meeting to order at 9 am.

PLEDGE OF ALLEGIANCE

President Barcellos led those in attendance in the Pledge of Allegiance.

ACTION ITEMS

BOARD TO HEAR A PRESENTATION FROM BOB NUNN OF SUNSET EXPLORATION ON THE PANOCHE DRAINAGE DISTRICT CARBON SEQUESTRATION PROJECT PROPOSAL

Mr. Nunn reviewed the proposal and presented a map of the property in the Panoche Drainage District that his company is suggesting for this proposal. Sunset Exploration currently has projects in the Merced, Madera, and Fresno area. Leases would be needed from not only the landowners, but the mineral ownerships, as well. Mr. Nunn explained that there are 3, possibly 4, different 200 feet sandstones in this area that the District can try to monetize and create a revenue stream from and that we also meet the requirements that the EPA has. Once established, the EPA would mandate monitoring wells of their

choosing to ensure the carbon removal/movement is going to plan. Right now, there is robust state support for these types of projects. Initially the carbon would be moved by rail, but there are several old pipelines in place in the area to tie into. Mr. Nunn also explained that if Sunset Exploration has leases in place for at least 75% of the ground and mineral ownerships, the remaining 25% can be force-pooled by the state. There are benefits to the District, landowner, and mineral ownership leasing to Sunset Exploration. One being a tax credit of \$85 per ton available, an annual lease payment to both the landowner and mineral ownership, and injection payments with annually increases tied to the GNP index. The leases could run longer depending on the volume brought in and Sunset Exploration would bear the liability and the risk. After a few questions from the Board, it was suggested that Mr. Nunn come back with a Letter of Intent to be voted on at a future meeting.

GRASSLAND BASIN AUTHORITY

The General Manager of the Grassland Basin Authority Mr. McCoy reported on the following:

- The Authority will not be able to produce a second cutting of wheat grass based on limited drain water irrigation supplies.
- The Jose Tall Wheat Grass revenue will continue to be less than budgeted by approximately (\$800,000). They do have \$1 million in reserves which is able to help offset that total.
- Construction is moving forward and an electrical contractor is out there right now.
- Pistachio Harvest starts tomorrow on 4 fields.
- The next GBA meeting will be held in November of 2023.

GENERAL MANAGER'S REPORT

General Manager Mr. McGowan reported on the following:

A. Prop 84 Grant for Westside Regional Drainage Plan

On October 16th Mr. McGowan, Mr. McCoy, Mr. Linneman and DWR took a tour.

- i. Reimbursement Summary: The District is still waiting on a couple of reimbursement requests made to the Department of Water Resources (DWR), 13 and 14, which have already been docusigned. The District did receive payment reimbursements on 9, 10, 11, and 12.
- ii. Cash Flow Analysis: The Board requested to see a full recap of all of the grant detail at the November meeting.
- iii. Tile Sump Scada Project: Mr. McGowan relayed that the contractor has erected the two antenna sites locations and that PG&E is in the process of giving PDD an exemption to continue the project.
- iv. Land Acquisition: No update.
- v. Other: None

Mr. McGowan let the Board know that Fresno County LAFCO is not open to the idea of hopscotching the Nelson property in order to annex in the other existing three properties. We are moving forward with our discussions with LAFCO and property owners.
